## Caravan Hire Agreement.

### Medcasa Caravans agrees:

1. To supply caravans for **stationary hire only**, unless by arrangement with owner. Caravan sites must be ready by requested delivery date so caravans can be set up and secured/immobilized by owner.
2. Repair fair wear and tear breakages, also to repair leaks if any occur.
3. Caravans are supplied in tidy condition, swabs with clean covers.  
Additional equipment supplied: Fridge, Power Lead.
4. All caravans have current electric warrant of fitness when hired.

### Hirer agrees:

1. To be responsible for the **security** of the caravan and equipment until caravans are de-hired and ready for return to owner, to return the caravan in the same condition as delivered, except for fair wear and tear.
2. No naked flames i.e. gas heaters, candles etc. are to be used inside caravans under any circumstances.
3. To keep caravans reasonably clean and tidy at all times, and are to report promptly any damage so repairs can be made.
4. **26 weeks minimum hire per caravan at the price of \$29.00 per week.**
5. **Payments are to be made weekly/fortnightly by an Automatic Payment.**
6. **If the caravan is returned prior to 6-month period expiry, price per week will be re-calculated to \$65 per week, difference paid on the caravan return.**
7. **To pay \$100 Bond + 1 week rent in advance.**
8. **Agrees to give 4 weeks notice on return of the caravan**
9. Failure to comply with these conditions may result in immediate repossession of the caravan.
10. Damage repair/ replacement arrangement:  
Any damage or loss of contents/equipment beyond fair wear and tear will be charged against the hirer, depending on nature of the repairs (if a contractor is engaged - time, travel, parts and materials).  
If returned caravans require cleaning to pre-delivery condition, a cleaning fee may be charged on an hourly rate.
11. Debt Collection costs for unpaid rent, if occurred, are paid by the hirer.
12. Hirer agrees to disclose their credit score, done through **clearscore.co.nz**
